

The main output of the ERMIS project is the elaboration of an innovation systems model designed to boost enterprises within the regions involved in the project. "It is to be expected that European regions differ quite strongly in their ability to develop a regional innovation system". For the past 6 months we have been in the process of identifying characteristics of each region's local innovation system, in order to design guidance procedures & criteria for a SWOT analysis", says Ludovic Di Biaggio, ERMIS Innovation Expert, leading the research.

Zoom on the ERMIS SWOT Analysis process!

ERMIS partners are currently gathering relevant information through a SWOT analysis (strengths, weaknesses, opportunities & threats) of partner regions, in order to define and support the development of local and regional policies stimulating the innovative performance of SMEs as a source of sustainable growth. This will guide future action plans in the project. This SWOT will help analysts evaluate their region on the basis of the relevance and effectiveness of policy actions in place enhancing the innovative capacities of local SMEs.

Caroline Mancel, keynote speaker at the Brussels briefing began her talk with interesting references to the priorities of the Belgian presidency and commented on recent policy updates at EU level. She commented that, "all relevant stakeholders of the Innovation Union have to be involved if the EU 2020 is to be achieved".

She added, "an innovative way to achieve an integrated market approach was proposed through the European Innovation Partnerships (EIP). This aims at fostering synergies and mobilizing expertise & resources across the innovation chain throughout Europe, by combining supply and demand policies in order to bring innovation with societal benefits more rapidly onto the market place". She went on to highlight the current European economic climate with its budgetary constraints, and situated the Belgian Presidency in the context of the institutional changes taking place within European Parliament new Commission, currently in place for a five-year term.
